Emissions reduction targets

Eleventh Hour Group intends to begin measurement of carbon emissions as a result of its business activities by the end of 2025.

We plan to ensure that environmental initiatives are embedded within the growth of our organisation and will adopt measures to reduce and eliminated harmful emissions associated with our business activities.

Following identification of our baseline, we propose to implement targets to halve emissions within 5 years, reducing emissions by 80% by 2035, and achieving net-zero by 2040.

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented to date;

- Publishing of a Carbon Reduction Plan, in accordance with PPN 06/21
- Formulation of an Environmental Sustainability Policy
- Promotion of environmental awareness to staff as part of induction and ongoing training including use of public transport and bike/walk to work
- Implementation of a digital-first meeting approach
- Identification of greener suppliers of goods & Products purchased by the company
- Commenced conversations with property landlords on selecting greener utility suppliers

In the future we hope to implement further measures such as:

- More robust recycling schemes
- Exclusive use of green energy suppliers
- Use of Electric Vehicles and public transport for company journeys
- Carbon offsetting for unavoidable emissions
